



Winter Camp Fees, Terms & Conditions 2023

To apply for a place at Surval Winter Camp please complete the Application Form and return it with payment of CHF 2'500.- which covers the Application Fee (non-refundable) CHF 500.- and Deposit CHF 2'000.-

The Deposit serves as a guarantee throughout your daughter's time at Surval Winter Camp and is refunded on completion of the course, less any 'extras', subject to no outstanding sums of money being owed to Surval Montreux.

Please be advised that if any costs arise due to damage to property, this will be charged to the account of the student involved.

Winter Camp Fees cover the following:

- Surval Core lessons: language tuition (French or English), Etiquette, Communications, International Relations, Culinary Arts
- 3 days of skiing each week including group ski instruction and transport
- Winter sports activities programme
- Cultural excursions within Switzerland
- Hire of ski equipment
- Loan of textbooks and other materials for class (unless student chooses to write in them)
- Use of facilities, fitness suite, library and access to the Internet
- Ensuite accommodation and all meals. Accommodation during residential trips is in chalet-style hotels
- Laundry (excluding dry cleaning)
- Provision of all linen
- Residence tax (taxe de séjour)

Admissions Contract

The Contract between (Parents/Legal Guardians) and Surval will commence on formal acceptance of a place at Surval Montreux.

Application Fee

With the application, please submit proof of payment of CHF 500. This fee covers administrative costs and is not refundable under any circumstances.

Deposit

The Acceptance Deposit serves as a guarantee and will be refunded within 60 days after the end of your daughter's final term at Surval Montreux, subject to no outstanding sums of money being owed to the School.

Personal expenses

Your daughter's personal expenses and pocket money will be deducted from her Deposit and final statement will be sent to you at the end of the Winter Term.

Insurance

Health and Accident Insurance is compulsory for anyone residing in Switzerland. All students at Surval are covered by the School's insurance policy.

Payment Plan

The Winter Camp fees are due on 1 November 2022.

All invoices must be paid in full. In case of late enrolment, fees are due upon receipt of the invoice.

Annual default interest of 10% is charged for any late payment, as well as a fee for issuing reminders (CHF 50 for second reminder, CHF 100 for additional reminders).

Cancellation and notice of withdrawal

Any termination of the contract must be notified in writing to the Principal.

- The Application Fee is not refundable.
- Notice Deadline: 15 September 2022.
- If notice to cancel or withdraw is received before the Notice Deadline, the Acceptance Deposit will be retained.
- If notice to cancel or withdraw is received after the Notice Deadline, parents will be required to pay the full fees for the Winter Camp.
- In case of expulsion, only the balance of the student's Personal Account will be refunded.

Applicable Law and Competent Court

The General and Financial Conditions and all contractual agreements between the Parents and Surval Montreux are solely subject to Swiss Law, irrespective of where Parents may reside. Legal residence is elected in the Canton of Vaud, Switzerland and any dispute arising from the contract between the Parents and Surval Montreux will be submitted for decision to the local court of Montreux/Vevey.

School Code of Conduct

We want each girl to enjoy her time at Surval and take full advantage of all the exciting things we offer. Please remember we are all here to help and to ensure that your time here is a positive and enriching experience.

Surval's core values are centred around Honesty, Openness, Courage and Curiosity. Living here together is based on Courtesy, Consideration and Care for each other.

Below are the principles we all live by:

- Surval does not tolerate bullying, harassment, racist language or other kinds of unacceptable behaviour.
- Students must assume responsibility for their personal safety. We do all that we can to create a safe environment for our students, but students must also play an active role in ensuring their own safety by being sensible, exercising caution and maintaining awareness of their surroundings.
- Surval does not tolerate any behaviour prejudicial to the health, safety or wellbeing of others or to the reputation of Surval.
- Theft is not tolerated – students must keep all valuable things in their personal safe.
- The possession and/or consumption of alcohol is forbidden unless a specific permission has been given. Alcohol tests may take place.
- Surval is a non-smoking school. Smoking anywhere on the school campus or during trips/excursions is strictly forbidden
- The possession, trafficking and/or use of drugs either at school or off campus will result in automatic exclusion. Drug testing may take place.
- We reserve the right to inspect or search rooms and personal belongings at any time. We exercise this right in the event of suspected theft, tobacco, alcohol or drug use or other serious concerns. In these cases, students' electronic devices may also be searched.
- Surval Montreux reserves the right to exclude students who do not follow this Code of Conduct.

Please note that the Swiss Law prohibits:

- The sale of tobacco to those under the age of 18.
- The purchase and consumption of alcohol by those under the age of 16.
- The consumption of alcoholic drinks other than wine and beer by those under the age of 18 (beer and wine are permitted from age of 16).
- The production, sale and consumption of all drugs.
- Entry to bars, discothèques, games arcades and casinos for those under 16 unless accompanied by an adult.
- Under 16s cannot be out unsupervised in the evening after 22.00.
